Sealed Limited Tenders, should be sent by post or can be dropped at TENDER BOX placed at the office of Commandant 2 Bn NDRF, Digberia Camp Badu Road (Barasat) Kolkata-700129 on or before 6th Sept'2011 by 1100 Hrs.

04. All the tenderers are required to follow two bid systems i.e. Technical Bid and Financial Bid separately. The tender documents be submitted in three different covers as under:-

THIRD COVER	:	FINANCIAL BID – Should contain following documents.

	iii.	The rate must not under any circumstances be altered.
	iv.	Rate so offered should be entered in words as well as in figures.
	v.	FOR & terms of delivery.
	vi.	Rate quoted should be valid up to the end of current financial year i.e. 2011-12 which should be clearly accepted in the Financial Bid which may be further extended with the concurrence of the firm.

05. Tenders will be opened by a duly constituted Board of Officers on 6th Sept’2011 at 1200 hrs in the office of Commandant 2 Bn NDRF, Digberia Camp, Badu Road Kol-700129. Representative of the firms are at liberty to be present at the time of opening of tenders. The tenderer shall have to demonstrate the item before a Board of Officers on the date of opening of

tender at this HQ for technical evaluation. If the firm fails to conduct demonstration, the tender will be subject to rejection.

06. Tenderers are required to submit Earnest Money Deposit of Rs.30,000/- (Rupees Thirty Thousand) Only for (REFLECTIVE JACKET-WATER PROOF) in the shape of Bank Draft/Bankers' Cheque drawn in favour of Commandant 2 Bn NDRF payable at STATE BANK OF INDIA, BARASAT, along with the Tender Documents. Earnest Money of unsuccessful tenderers shall be refunded to the firm after completion of the tender formalities and that of successful tenderer after completion of supply of stores.

07. The successful tenderer require deposit Security Money @ 5% of value of supply order and execute an agreement before placing supply order on hearing from this HQ.

08. The tenderer will supply the stores at HQ 2 Bn NDRF, Digberia Camp, Badu Road Kolkata-700129 within stipulated period as mentioned in the Supply Order and in case firm fails to supply the stores within delivery period, the Earnest Money Deposit/Security Money as deposited by the firm shall be forfeited and deposited into Government Treasury.

09. Stores will be supplied on credit basis. Bill will be accepted against delivery of stores. Payment will be released through Bank Draft by Commandant 2 Bn NDRF on proper receipt.

10. Tender not fulfilling any of the above terms & conditions shall be summarily rejected and no representation will be accepted.

11. In the event of failure on the part of the Tenderer to fulfill all or any terms & conditions laid down herein, it shall be lawful for the Commandant 2 Bn NDRF to forfeit a part or whole of the Earnest Money/Security Money Deposit.

12. The Commandant 2 Bn NDRF, Kolkata reserves the right to reject or accept any Tender(s)/stores without assigning any reasons. The stores supplied by the firm are subject to acceptance after survey by a Board of Officers. In case of rejection of stores, the firm will be responsible to lift the stores and to provide its replacement within a specified time at their own risk and cost.
