LIMITED TENDER NOTICE

Sealed Tenders are hereby invited by **The Commandant, 9 Bn NDRF (BSF)**, Bihta, Post: Bihta (Patna)- 801103 on behalf of the President of India for procurement of **COLLAR STIFF NECK REGULAR** for **National Disaster Response Force, Bihta, Patna**. Estimated cost of Stores is Rs. **3,16,800/-** (Rupees Three Lakh Sixteen Thousand Eight Hundred) only.

INSTRUCTIONS FOR BIDDERS & CONDITIONS OF CONTRACT

1. Sealed Tenders along with product details in a two bid system are to be deposited in the Tender Box placed in the office of the Commandant. 9 Bn NDRF, Bihta, Post- Bihta (Patna)- 801103, on or before **20 Sept 2011 at 1200 HRS.**
2. Envelops should be super scribed with the Tender No. and Date.
3. Tenders will be opened in the presence of the bidders on **20 Sept 2011, Tuesday at 1600 HRS** by a duly approved Board of Officers/TPC.
4. Improper or incomplete Tenders or Tenders without specifications will be rejected.
5. All tenders are to be accompanied with a Demand Draft of Rs. **6,336/-** (Rupees Six Thousand Three Hundred Thirty Six) only drawn in favour of the Commandant 9 Bn NDRF, at **SBI, Bihta, (code No: 1217)**. This is to be retained as Earnest Money from the bidders.
6. Bank Drafts of unsuccessful bidders will be returned after the completion of the bidding process.
7. Cost of the product and taxes should be written separately. "FOR" of the product will be campus of 9 Bn NDRF, Bihta (Patna).
8. All tenders without detailed product specifications will be rejected.
9. **The tender process will be in TWO BID SYSTEM under rule GFR 152. In the first cycle only product specification conforming to the specifications will be selected. And further only quotations of tenders whose product specifications have been selected, will be entertained.**

10. All bidders are requested to submit their offers in two covers as under:-

a) **FIRST COVER** should contain the following: -

- i) Tender documents duly completed and signed BUT WITHOUT INDICATING THE RATES QUOTED.
- ii) Earnest Money.
- iii) F O R, terms, delivery period quoted.
- iv) Copy of firm registration and Dealership certificate if available.
- v) Any other relevant documents which the firm wishes to submit.
- vi) Sample of the item for which tender has been called.
- vii) Specifications of the product.

b) **SECOND COVER** should contain the following:-

- i) Details of rates, taxes, duties, discount, if any, quoted by the bidder. These details should be submitted on their letter pad with stamp.
- ii) Both the above mentioned covers should be sealed separately and super-scribed with the Tender No, stores and date of tender opening.
- iii) These covers should thereafter, be kept in a third cover and again sealed.
- iv) This cover should also be super scribed with the Tender No, Stores and Date of Tender Opening.
- v) The composite bid i.e. rates indicated in the Technical Bid OPENLY IN TENDER IS LIABLE TO BE IGNORED.
- vi) Rate quoted by the firm should be on firm price basis.

(Only the first cover shall be opened on the date of opening. Price bids of only those firms will be considered for tender opening whose offer is complete in all respects and the tender samples submitted by them are approved/qualified)

11. All tenders are to be accompanied with a copy of the Sales Tax Registration, VAT Registration of the firm & xerox copy of PAN CARD.

12. Successful tenderers should supply the material within 30 days from the date of receipt of the supply order.

13. **Successful bidders will have to supply the Goods within 30 days of placement of Supply Order by this office, On intimation they are required to provide advance sample before placement of supply order or supplying the whole consignment for assessment and also deposit 10% of the amount of total cost of goods as security deposit by Bank Draft, which will be returned after full and satisfactory supply of the goods.**

14. This period may be extended for further 15 days in case of any delay due to any unnatural circumstances at the sole discretion of the Commandant 9 Bn NDRF.
15. Commandant, 9 Bn NDRF has the power to reject any tender or all tender without assigning any reason or extend the date of opening of tender without citing any reasons. Decision of Commandant 9 Bn NDRF will be final and binding to all Tenderers.

SPECIFICATIONS OF COLLAR STIFF NECK REGULAR

QUALITATIVE REQUIREMENTS

The collar stiff neck regular should have following features:-

COLLAR STIFF NECK REGULAR (AS PER IS: 11569)

- Rigid cervical collar-extrication type
- Material: soft plastic rigid enough to avoid 70% of neck movement and lined inside with soft cushion.
- Padded chin rest for application by sweep technique.
- Colour coded and measure holes for easy identification and measurement of correct size.
- Velcro for easy fixation.
- MRI/CT Scan compatible; radio lucent
- Tracheal access opening for advanced airway procedure;
- Rear panel opening for cervical spine palpation
- Latex free and durable
- This size of finished c-collar should not be less than 6 cm when measurement as per prescribed procedure.

NOTE TO TENDERER

- i) The tenderer shall indicate the make/model in their offer.
- ii) The tenderer shall furnish the clause-by-clause compliance statement. In case there is any deviation the same should be clearly brought out in the offers.
- iii) They shall mention the relevant BIS/EN/DIN/UL certificate of the product offered.

- iv) Technical manual comprising of servicing details shall be supplied with system.
- v) Relevant test certificates if applicable shall be provided from a Govt. approved laboratory or from the manufacturer, along with this offer.
- vi) Items will be purchased on the basis of quality, price and samples. Rates should be valid till **31st Dec 2011**.
- vii) Tenders received without sample will not be entertained.
