

(Tenderers are advised to read the instructions carefully before submitting their offer/Quotations)

01	The Tenderer has to declare that, the store supplied to the purchaser under this contract shall be of the best quality, good workmanship, should be new and shall be strictly in accordance with the specifications and particulars contained/mentioned in the tender form. If the said stores are found not to conform to the description and quality mentioned aforesaid stores will be rejected, the decision of the purchaser in that behalf shall be final and binding on the firms and purchaser should be entitled to call upon the tenderer to rectify or replace the stores within specified time. ii) The purchaser shall be entitled to recover the cost with all expense from the tenderer for such defective/inferior stores and same will be returned to firm concerned on freight to pay basis at their own risk and cost.
02	The purchaser will not pay separately for transit insurance and the supplier will be responsible till the entire stores delivered in full and good condition at Commandant 1 BN NDRF, Patgaon P.O.- Azara, Dist :- Kamrup, Assam-781017. The supplier will be responsible for any loss or damage to the stores that may occur during the transit.
03	The price quoted should be on firm basis including all delivery charges/Sale Tax/VAT/Excise duty etc valid upto 31-12-2011 with FOR at Commandant 1 BN NDRF, Patgaon P.O.- Azara, Dist :- Kamrup, Assam-781017 clearly shown separately on the quotations. The price should be quoted in Rupees/paisa and quantity.
04	CST/GST/VAT/LC Numbers of the firms should be clearly mentioned in the quotations.
05	The representative of the firms who responded to our tender enquiry can be present at the Office of the Commandant 1 BN NDRF, Patgaon P.O.- Azara, Dist :- Kamrup, Assam-781017 at the time of opening of tenders on 08th July 2011 at 1600 Hrs.
06	Stores required such as Tyres/Tubes/Flaps which are manufactured by various companies no requirement to produce the samples, but make and brand of each tyres/tubes/flaps as per above sizes should be quoted on the quotations.
07	The tenderers should submit the following documents along with their quotations failing which their tender will be rejected :- (a) Photo Copy of latest valid sale taxes clearance certificate not more than one year old. (b) Preference if any will be given to the firms who have past experiences of similar type of store. © Latest income tax clearance certificate.
08	Earnest money Deposit (EMD) to the tune of Rs 35690.00 (Rupees Thirty five thousand six hundred ninety) only should be sent in the form of Account payee demand draft in favor of Commandant 1 BN NDRF, payable of SBI, Maligaon, (Code No 0229) along with the quotations.
09	No interest shall be payable by the purchaser on the EMD deposited by the tenderers.

10	EMD. of un-successful tenderers will be returned back as early as possible. Hence tenderers are requested to send a pre-receipt challan along with quotations, so that refund of EMD can be made well in time.
11	The tender/quotations may be sent by Registered Post/Courier/Speed Post to Commandant 1 BN NDRF, Patgaon P.O.- Azara, Dist:-Kamrup, Assam-781017, By hand tender/quotations will not be entertained. Tender received after specified date and time i.e. at 1500 Hrs on 08 th July'2011 will not be entertained under any circumstances.
12	The Tenderers whose rates are approved have to deposit 5% of the stores as security money. On receipt of the security money, EMD will be returned to the tenderer, Cash security deposit will not be accepted. The security deposit will be returned subject to supplier being made in full within the stipulated period of delivery.
13	If the tenderers fail to deposit, the security money @ 5 % of cost of the stores within the time limit of 15 days on acceptance of tender, the EMD will be forfeited.
14	If the supplier fail to supply the stores within the stipulated period of 45 days (Unless extended) the security money will be forfeited. No extension in delivery period will be entertained without L.D. which shall be charges @ 2% of the value of delayed supplies per month.
15	The firm should submit/send the tender with proper sealed envelope duly endorsing full address of the firm, Tender Notice Number, Date of Tender , Due Date and Time should be written in bold letter on the top of the envelopes and quotations for " TYRES/TUBES AND FLAPS"
16	Payment of stores is likely to be made within two months from the date of receipt of complete stores/bill.
17	The store will be delivered at the office of the Commandant 1 BN NDRF, Patgaon P.O.- Azara, Dist :- Kamrup ,Assam-781017 on receipt of stores by Commandant 1 BN NDRF will be checked by a board of officers including Technical member detailed by this unit and if any item is found inferior, the stores will be rejected and rejected store will have to be taken back by the supplier at his own cost and risk.
