NOTICE INVITING TENDER

National Disaster Management Authority invites quotation for disposal of one staff Three Wheeler No. DL 1LH 2498 (Bajaj Auto) on "AS IS WHERE IS BASIS". Interested parties can inspect the vehicle on any working day between Monday to Friday between 11.00 A.M. to 3.00 P.M. from 20.12.2022 to 27.12.2022 at "NDMA Bhawan", A-1, Safdarjung Enclave, New Delhi – 110029 (contact person, Shri Devreen Bhakta, Section Officer (Phone: 011-26701270). The quotation in enclosed proforma in sealed cover superscribed "Tender for disposal of one Staff Three Wheeler No. DL 1LH 2498 (Bajaj Auto)" should be sent to the Under Secretary (General), "NDMA Bhawan", A-1, Safdarjung Enclave, New Delhi – 110029 or the bid document completed in all respects along with 'Bid Security Declaration' and other requisite documents may be put in the Tender Box kept in the reception area of NDMA. The last date of receipt of quotation is by 2.00 P.M. on 27.12.2022. The bid shall be opened on the same day at 3.30 P.M. in the Dining Hall of NDMA. The tenderers, who wish to be present at the time of opening, may do so. The terms and conditions of the contract are as follows:-

TERMS AND CONDITIONS OF THE DISPOSAL OF one staff Three Wheeler No. DL 1L H 2498 (Bajaj Auto):

- 1. As per the directions of the E&M Workshop, Airport Authority of India and State Transport Authority, Govt. of NCT of Delhi, the transfer of ownership of auctioned/condemned vehicle cannot be considered. However, a "No Objection Certificate" may be obtained from the Registering Authority for such vehicle for reregistration elsewhere outside NCR Region. The formalities have to be completed by the purchaser.
- 2. The 'Bid Security Declaration' should accompany the bid. The bids without 'BSD' will be summarily rejected.
- 3. The bids received after the stipulated date and time i.e. after **02.00 P.M**. on **27.12.2022** will be summarily rejected. The bids received through E-mail/Fax/Telegram will not be considered. However, bids through speed post/registered post/courier will be considered only if received before the stipulated date and time.

- 4. The prospective bidder has to submit authenticated documentary proof of his address. The Department reserves the right to verify the antecedents/ documentary proof of his address. In the absence of the information the bids shall not be entertained.
- 5. The bids with overwriting/cutting in the quoted rates will not be considered.
- 6. The Bid value of the vehicle no. DL1LH 2498- Bajaj Auto Three Wheeler has been calculated Rs.12,250/- (Rs. Twelve thousand two hundred fifty only) i.e. Rs.25/- (Rs. Twenty-five only) per Kg. As per the RC, unlaiden weight of Three Wheeler is 490 Kg. The successful bidder has to deposit earnest money (not less than 25% of the bid value) should immediately be deposited on the spot either in cash or in the form of Deposit-at-Call-receipt (DACR), draw in favour of the DDO, NDMA. The goods/vehicle will be handed over to the successful bidder only after receiving the balance payment
- 7. The vehicle has to be taken away by the successful bidder from "NDMA Bhawan", A-1, Safdarjung Enclave, New Delhi 110029, within 2 days after acceptance of the quotation of the successful bidder. The bid amount by the successful bidder will be deposited in favour of DDO, NDMA.
- 8. The disposal will ordinarily be in favour of the highest evaluated bidder, whose bid is found to be responsive and who is eligible & qualified as per term & conditions.
- 9. Successful bidder may be intimated for removal of sold vehicle at his own expenses. No assistance / transportation will be provided by NDMA. Permission to take out the disposed vehicle from NDMA premises will not be allowed on holidays, Saturday and Sunday, etc.
- 10. In case the highest quoting firm fails to honour the bid, the next opportunity will be given to the next highest quoting eligible bidder (H2 firm).
- 11. The vehicle shall be used for bonafide/lawful purpose only.
